Toilet Rebate Program

Toilet flushes and leaks can eat up nearly 40% of your *indoor* water budget. If your home or business contains toilets purchased before 1992, you may be using anywhere from 3.5 to 7 gallons with each flush.

Today's **High-Efficiency Toilets (HETs)** do the job using just 1.28 gallons or less. So replace your water-wasting toilet with an HET, and receive a \$100 rebate from the Napa Sanitation District. You'll save water & money!

To qualify for the toilet rebate...
it's as simple as 1, 2, 3.

1. You must be connected to the Napa Sanitation District sewer system.
2. You must replace 3.5 to 7 gallon toilets with an EPA WaterSense labeled High Efficiency Toilet (HET) that uses 1.28 gallons or less.
3. You must have the old toilet(s) in your possession.

If you meet the rebate criteria, contact the Napa Sanitation District for an **Authorization to Proceed** form.

Follow the steps for turning in your old toilet and receiving your rebate.

Toilet Rebate Program Guidelines

1. You are eligible for a one time rebate per toilet for each property. Once a toilet is replaced under this program, it is ineligible for future rebates.
2. To receive the rebate, you will need an **Authorization to Proceed** form. You can obtain this form by going to the District office, at 1515 Soscol Ferry Road, Napa, or you can call the District at (707) 258-6000 to receive a form in the mail.
3. You must replace your 3.5 to 7 gallon toilet with an EPA labeled WaterSense High Efficiency Toilet (HET). See www.epa.gov/WaterSense/products/toilets/html for more information.
4. You must deliver your old toilet to the City of Napa Corporation Yard at 770 Jackson Street. **IMPORTANT:** The only time your toilet(s) will be accepted at the Corporation Yard is as follows: On **Monday between the hours of 9:00 a.m. to 10:00 a.m. and 2:30 p.m. to 3:30 p.m.** There are no exceptions – these are the only times the toilet(s) will be accepted. **ALL HARDWARE AND THE TOILET SEAT** must be removed from the tank & bowl. The City Corporation Yard will only accept the **ceramic** portion of the toilets. **IF THERE IS ANY HARDWARE ON THE TOILET, OR THE TOILET SEAT HAS NOT BEEN REMOVED, THE TOILET WILL NOT BE ACCEPTED AT THE CORPORATION YARD. YOU MUST UNLOAD YOUR TOILET(S) YOURSELF AT THE CORPORATION YARD.**
5. Your **Authorization to Proceed** form must accompany your old toilet(s) when you arrive at the Corporation Yard. Once you have unloaded your toilet(s) at the Corporation Yard, the form will be signed off and you will be given a copy. Keep the copy of the form. It is the only proof you have that your claim is in the system.
6. City personnel will inspect installations to verify the number and type of toilets installed.
7. City personnel will send a completed copy of the Authorization to Proceed form to the Napa Sanitation District. Upon receipt by the District, your claim will be processed. **PLEASE ALLOW FOUR WEEKS FOR PAYMENT.**
8. You have 30 days from the date on the **Authorization to Proceed** form to complete the work and turn the old toilet into the City Corp. Yard. The **Authorization to Proceed** form will become null and void after 30 days.
9. Retrofits required of developers by the City as mitigation measures for additional connections are not eligible.



NOTE: IF THE NUMBER OF RETURNED TOILETS IS LESS THAN THE NUMBER OF REPLACED TOILETS, THEN REIMBURSEMENT WILL BE FOR THE NUMBER OF TOILETS RETURNED.
